Terms of the Tender:

- 3- The Gypsum board works materials involved within the tender must be in line with the below mentioned criteria:

3	Providing material and requirements for installing bordex directly on the wall.		

- 4- The materials involved within the tender must be of good origin and have a quality certificate showing that.
- 5- The material shall be in accordance with the specifications in the tender offer list and otherwise, the tender shall be canceled. If any material is found to be in violation of the specifications mentioned upon receipt from the Company/Supplier that will be awarded the tender, Heevie shall have the right to cancel the agreement.
- 6- In case of delay in preparing and processing in the agreed period, the Company/Supplier shall bear a delay penalty of (150,000) one hundred fifty thousand Iraqi dinars for each day of delay, and in case of delay more than one month, the contract shall be canceled.
- 7- The provided tender must be completed regarding the single and the total accounts, otherwise it will be neglected.
